Job Description: Junior Counselor

Reports to: Program Coordinator

Minimal Qualifications:

- · Active Christian faith
- · Must have just graduated high school
- Ability to perform potentially strenuous physical activities (hiking, field games, water activities)
- · Willingness to learn new things
- · Ability to work well with others
- Desire to support and serve both campers and staff
- Willingness to support the theological doctrine and practices of the United Methodist Church

General and Specific Responsibilities:

- Be open and willing to participate in and lead camp activities
- Assist Counselors in leading cabins through daily schedule
- Be open and willing to participate in and lead worship in a variety of different ways
- · Attend and participate fully in staff training prior to camper arrival
 - As you are able due to your school schedule
- Be open and willing to facilitate camp activities through setup, tear down, and background tasks.
 - Cleaning
 - Sanitizing
 - Facilitate Check-in and Check-out parking
 - Assist at Camp Store and Snack Shack
 - Food Service
- Attend mandatory Junior Counselor Training Retreat (Date will be communicated to you)

Advancement Opportunities:

- Successful Junior Counselors may be asked to lead cabins in camps like Mini-Camp or small Elementary cabins. They may also be asked to participate in Day Camp.
- The typical Junior Counselor employment is initially only 5 weeks of summer (as chosen by you)
 - If you are successful in completing those weeks and we have need for more staff, you may be asked to continue on weekly for additional pay.

- Ability and desire to learn, perform, and teach certain outdoor skills and activities (fire building, rock climbing, wilderness risk management, etc.)
- · Comfortable with cultivating Christian Community through leading, teaching, and equipping others
- Ability to work well with others
- Willingness to travel with other Adventure Camp Staff and campers to various trip sites
- Desire to be in wilderness settings for extended periods of time and instill admiration for those settings in youth
- Willingness to support the theological doctrine and practices of the United Methodist Church

 - Personally responsible for up to 8 campers each week
 - Partner with fellow Adventure Camp counselors and their campers for all activities throughout the week
